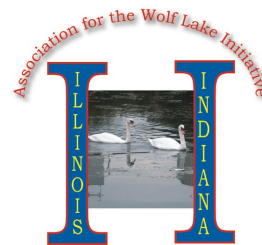

Mission and Purpose: *The Association for the Wolf Lake Initiative (AWLI) is a bi-state, not-for-profit organization and land trust. It seeks to improve and enhance Wolf Lake and surrounding natural areas in three ways.*

► *As custodian of the Wolf Lake Vision as developed by the Bi-State Gatherings on Wolf Lake of 2000-2001, AWLI pursues its primary goal by implementing the vision.*

► *AWLI promotes Wolf Lake by sponsoring annual festivals, conducting tours and sponsoring other activities.*

► *It advocates for improved policies and practices through its Vision Implementation Task Force. AWLI also convenes Community Meetings on Wolf Lake.*

Governed by a Board of Directors, AWLI is served by a 27-member Advisory Group. The Legacy Foundation manages a bi-state endowment fund for Wolf Lake established by AWLI.

Victor to head AWLI in 09:

Bob Victor will head the bi-state Association for the Wolf Lake Initiative (AWLI) in 2009 as president of its 17-member board of directors.

A resident of Highland, Victor is research manager for the South Shore Convention & Visitors Authority. He served as interim president of AWLI in 2008 and has served as a director since the organization's incorporation in 2003.

Other officers elected at AWLI's organization meeting on January 22 were Roy Ortiz of Hammond, vice-president; Dinah Ramirez of Chicago, secretary; Ken Czulno of Chicago, treasurer; and Mary Lu Gregor of Whiting, member-at-large.

Ortiz is a long-time advocate for improvements to Wolf Lake and is a member of the Wolf Lake Conservation Project. He is recipient of Hammond's Volunteer Citizen 2007 award.

Ramirez is executive director of Healthy Southeast Chicago and a registered nurse. She served as AWLI's vice-president in 2008.

Czulno was re-elected treasurer in 2009. He is the finance director of the Cook County Sheriff's Office.

Gregor is the executive director of the Whiting Robertsdale Chamber of Commerce. A former teacher and office manager, she serves as executive

Century later

It was 100 years ago that Daniel Burnham and a group of civic leaders announced their plan for the future of Chicago's lakefront and adjacent areas from Kenosha, Wisconsin to Michigan City, Indiana. Today, we see the results of such a bold and innovative plan:

► regional forest preserves,

► North Michigan Avenue,

► lakefront parks and transportation routes that provide easy public access, and

► Wacker Drive.

Two of AWLI's poster contests, which last year drew the most participation as well as largest number of schools participating, are among hundreds of programs included in the five-month celebration.

The wetlands festival contest precedes the opening of the Burnham

Pavilions at Chicago's Millennium Park. A work commissioned for Symphony and Chorus inspired by the *Plan of Chicago* precedes the poster contest at the 6th annual Active Living Faire.

At a February meeting Centennial Plan partners also learned:

► exhibits about the Burnham Plan and its legacies will be included in dozens of libraries, including one in Chesterton.

► a model of Chicago using cutting-edge technology will be displayed in the lobby of the Santa Fe building, where the 1909 plan was designed,

► neighborhood and suburban museums will present exhibits on water, transportation, art and design,

► other partners will sponsor lectures, tours, symposia, school

AWLI: a Burnham Plan Centennial partner in 09:

AWLI members recognize the significance of AWLI's poster contests and now so do the organizers of the Burnham Plan Centennial.

The Burnham Plan 100 group last year selected contests for both the 9th annual Wolf Lake Bi-State Wetlands, Wind & Water festival on May 23-24 and the Active Living Faire on October 2-3 to be part of this year's celebration. The contests are listed under the Wolf Lake Watershed Meets Daniel Burnham heading on the Web site:

In applying for the designation, AWLI wrote that "Burnham's desire of public access to recreation at no cost is accompanied by a responsibility of the public to help maintain public lands for future generations. These contests suggest that we all have a responsibility to make choices that will shape the way we live for generations and to do so in a bi-state way."

As in past years, the purpose of the contests is to begin instilling in the participants a spirit of stewardship for the lake's watershed.



Poster Contest Winners:

Entries from Hammond's Scott Middle School and Chicago's Matthew Gallistel Branch and St. Francis de Sales High School placed first in their respective age groups in the poster contest at the 8th annual Winter Wonderland at Wolf Lake festival held Sat., Jan. 17.

Franciso Vitela, a senior at St. Francis, Luna Mireles, a sixth-grader from Scott Middle, and Claudia Rodriguez, a fifth grader at Gallistel were awarded first-place prizes with other winners at 9:05 a.m. Saturday at the Environmental Education Center, 2405 Calumet Avenue, Hammond. They were among a record 417 students who participated.

The festival, free to the public, was sponsored by AWLI.

Others to receive prizes were second-place winners Claudia Cortez, a freshman at St. Francis, Estefany Salcedo, an 8th grader at Scott Middle, and Stephanie Zandy, a second-grader, at Hammond's Franklin Elementary School.

Placing third was Jorge Guevara, a junior at St. Francis, Meghan Gray, a sixth grader at Hammond's St. John Bosco Paola Muñoz, a seventh-grader at Gallistel, and Lizbeth Raygoza, a kindergarten student at Chicago's Henry Clay School. Meghan and Paola tied.

Winners received awards of \$25, \$15 and \$10, respectively. Winning posters will be displayed at the Wolf Lake Park information kiosk.

Ten entrants received honorable mention. They were Shane Burmistra and Blake Talbert from St. Francis,

Cortney Kielbania and Mike McCue of St. John Bosco; Lucya Mendoza, Ivette Angulo, and Roman Herrera of Gallistel; and George Kyriakakis, Alex Geizar, and Jamison Reyna of Clay.

The posters will be on exhibit at the Environmental Education Center and at the informational kiosk at Wolf Lake Park.

Reception to celebrate challenge success:

AWLI has met the \$2500 challenge grant of the Legacy Foundation and will celebrate the success at a wine and cheese reception on Thursday, April 16.

AWLI raised almost half of the amount through canisters displayed by some 27 retail stores and outlets. Owners of those outlets will be honored at the reception.

Business donors Land and Lakes Company, Dri-Rite Company, ZF Lemborder, and American Trust & Savings Bank, and individual donors also are invited to the celebration.

Green Summit returns May 9:

AWLI and the Active Transportation Alliance (formerly the Chicago-Land Bicycle Federation) will co-sponsor a bike ride through the Wolf Lake watershed on Saturday, May 9, as part of this year's 10th Ward Green Summit.

Although tentative at this stage, plans call for John Pastirik to lead the ride. From South Chicago riders should arrive at Wolf Lake about 10 a.m. They will then view parts of Eggers Grove, Forsythe Park, and areas in between.

AWLI also will erect passive displays at the two major facilities. Last year they were Villa Guadalupe and The Zone community center.

The final meeting of Summit planners is April 2 at Villa Guadalupe.

This will be the second year of the Summit, sponsored by the Claretians and CSI

Dunes BioBlitz May 15-16:

What some 130 scientists did in 2002 for the Wolf Lake watershed will be applied to the Indiana Dunes National Lakeshore this spring.

In a 24-hour period on May 15 and May 16, scientists will seek to find and identify as many species as possible. For the Wolf Lake watershed, the number was 2,257. The number increased by several hundred in subsequent months as additional species were identified.

The BioBlitz, co-sponsored by National Geographic and the National Park Service, begins at noon on May 15 following opening ceremonies. The inventory of 15 miles of shoreline and 15,000 acres of dunes, oak savannas, marshes, bogs, prairies, rivers, and forests concludes at noon, May 16.

A BioDiversity Festival follows from 1 to 4 p.m.

AWLI plans to have a display at the event.

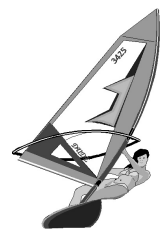

and community-based programs, university classes, and adult education.

The objectives of the celebration is to inspire and educate adults and children about both the Burnham Plan legacy and opportunities to make bold new plans for the region's future, advance enduring physical legacies that complete elements of the Burnham Plan, and initiate bold plans for the next century.

AWLI, as a partner in the celebration, should contemplate how we can improve the Wolf Lake watershed to be consistent with the century-old Burnham Plan. That's what we'll be asking high school students to do in the poster contest.

Greening of the Arts Reception and Show starts Oct. 24:

AWLI and South Shore Arts is sending invitations to artists to exhibit their work at the 4th annual Greening of the Arts Reception and Show from October to January, 2010.

The art show will begin Saturday, Oct. 24, at the Environmental Education Center, 2405 Calumet Avenue, Hammond, and conclude in January at Substation 9, Hammond Arts Center, 435 Fayette Street, Hammond..

Artists will set up their exhibits at the Environmental Education Center from 4:30 to 7 p.m. on Friday, October 23. The Art Show begins at 10 a.m. the next day. Exhibitors will have a chance to discuss their art at 11 a.m. at an artists' forum.

Lunch for exhibitors will be served at noon. The band, Just for Fun, will play from 5:30-6 p.m at a wine and cheese reception. As in past years, AWLI will have a raffle of crafts and

small gifts.

The Art Show closes at 8 p.m. and reopens at 11 a.m. Sunday.

Its Environmental Education Center portion concludes at 4 p.m.

Artists may remove their work then or beginning at 9 a.m. Monday.

Artists will then bring their works to Substation 9.

The Art Show features artists who use recycled products or who focus on nature and the environment.

AWLI credits NPS:

AWLI credited the National Parks Service for its help a decade ago in a statement submitted to the National Parks Foundation at its Town Meeting on March 4 in Chicago's Cultural Center.

The meeting was held to seek guidance and vision for the National Park System as it approaches its second century in 2016. The regional gathering attracted speakers from throughout the Midwest.

AWLI's statement reads as follows:

"This year marks the 10th anniversary of the Association for the Wolf Lake Initiative—AWLI as we call it. AWLI is indebted to the technical assistance provided our budding organization a decade ago by the Rivers, Trails and Conservation Assistance Program of the National Park Service. When I say budding, I mean a couple of ideas several of us threw together, but with no clear direction of where to go next.

"During our first two years, Rivers and Trails facilitated the development of a vision which continues to guide us today. We now are a sustainable bi-state conservation organization that works to preserve and enhance the Wolf Lake watershed in Southeast Chicago and Northwest Indiana.

"While we would have been successful without Rivers and Trails, their expertise sped the process. It brought us an enhanced mission and a

vision with the confidence to implement it. It brought us a greater understanding of working through partnerships and stakeholder building, and project credibility at such a crucial time for our success.

"It has been some time since we've asked River and Trails for help, but we know where to find them should we ever need more advice."

Wetlands festival shortened:

The 9th annual Wolf Lake Bi-State Wetlands, Wind and Water festival on May 23-24 is being shortened this year.

Sunday's Sunrise Service on May 24, with the Sunrise Singers and the Color Guard by the Polish Legion of American Veterans, will mark the end of the festival, instead of the start of day two. Plans for Saturday still call for canoeing and kayaking, fishing clinics, kite flying, and wind surfing instruction, according to AWLI's festival planners, the ***WWW.COM***-mittee.

As in the past, the festival will be free to the public.

Festival planners anticipate that groups collaborating this year will include the Hammond Port Authority, Chicago's 10th Ward Aldermanic Office, Hammond's Department of Parks and Recreation, Illinois Department of Natural Resources, Lake County Solid Waste Management District, Lake County Convention and Visitors Bureau, American Legion Illiana Post 220, Polish Legion of American Veterans, Chicago Public Library's Hegewisch and Vodak/East Side branches, East Side United Methodist Church, and Boy Scouts of America.
