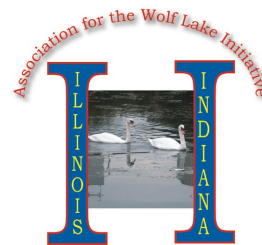

**Mission and Purpose:** *The Association for the Wolf Lake Initiative (AWLI) is a bi-state, not-for-profit organization and land trust. It seeks to improve and enhance Wolf Lake and surrounding natural areas in three ways.*

► *As custodian of the Wolf Lake Vision as developed by the Bi-State Gatherings on Wolf Lake of 2000-2001, AWLI pursues its primary goal by implementing the vision.*

► *AWLI promotes Wolf Lake by sponsoring annual festivals, conducting tours and sponsoring other activities.*

► *It advocates for improved policies and practices through its Vision Implementation Task Force. AWLI also convenes Community Meetings on Wolf Lake.*

Governed by a Board of Directors, AWLI is served by a 27-member Advisory Group. The Legacy Foundation manages a bi-state endowment fund for Wolf Lake established by AWLI.

## September deadline for poster contest:

Deadline is Friday, September 18 to enter The Wolf Lake Watershed Meets Daniel Burnham poster contest at AWLI's 6<sup>th</sup> annual Active Living Faire on Friday and Saturday, October 2-3.

## Keeping In The Loop

### *The birth of AWLI*

My personal introduction to the Wolf Lake watershed was attending a briefing held by the Illinois DNR near the conclusion of its diagnostic study of Wolf Lake and George Lake in 1995 or 1996. At the time I was representing the Calumet Ecological Park Association.

Several years later my focus returned to the Wolf Lake watershed when the Army Corps of Engineers began meeting with the Hammond Parks Foundation and Friends of Wolf Lake in 1999 on ways to enhance Wolf Lake. That was the time when the Lake Calumet Ecological Partnership was meeting at Chicago State University and the Calumet Heritage Partnership was meeting at Gibson Woods.

Groups in Southeast Chicago and Hammond had been activated to fight off plans to develop Chicago's third airport. They then began applying this energy to the improvement of the neighborhoods, including the

natural communities..

Within this whirlwind of interaction taking place between community groups and state, federal and local agencies, AWLI was born. It formed in late 1999 as a collaboration of the Calumet Ecological Park Association and Friends of Wolf Lake, known as CEPA/Friends of Wolf Lake. The proposal for this new group was then approved in concept by the Calumet Heritage Partnership in November 1999. That same month it joined the Lake Calumet Ecosystem Partnership. Although AWLI was not incorporated until late 2003 or recognized as a 501c3 until early 2004, I look back to the last century to mark the birth of AWLI.

That's why we plan to recognize a decade-long contribution on November 14. We wish that it be more than a celebration among AWLI members, but that residents who enjoy the Wolf Lake watershed participate as well.
