Members of the Association for the Wolf Lake Initiative (AWLI) elected three new directors at its January 13 annual meeting.

Elected to three-year terms on the board are Marianne Kozlowski of Chicago, Dr. Michael Galbreath of Peotone, and Dr. Valerie Pennanen of Hammond.

Kozlowski, a retired bank administrator, is co-steward at Eggers Grove, of the Cook County Forest Preserve District of Cook County. She also is a member of the Calumet Nature Exchange.

Galbreath is a retired regional school administrator of Chicago suburban schools, former coach and college professor. A US Peace Corps volunteer, he is a graduate of Calumet College of St. Joseph.

With a masters degree from Cardinal Stritch University, he earned his doctorate from the University of Illinois, Urbana.

Galbreath has written numerous articles on religion and education.

Pennanen is a history professor at Calumet College. With undergraduate training at Bryn Mawr College, she attended the University of Michigan for her masters and doctorate degrees in classical art and archaeology.

She recently had published an essay on "Mister Rogers' Neighborhood" and several book reviews in the Journal of Popular Film and Television.

Pennanen is co-host with AWLI of Calumet Revisited Forums. Her special interests includes environmental stewardship.

The three directors will attend their initial board meeting on January 29.
